# CONSTITUTION AND RULES BHARAT UDAY PARTY OF INDIA

## **Preamble**

We, the members of Bharat Uday Party, having resolved to uphold the democratic, secular, and socialist values of the Indian Constitution, do hereby adopt this constitution to provide a framework for the governance and administration of our party, to guide our actions and policies, and to achieve our political objectives in service to the people of India.

## **Article I: Name & Symbol of the Party**

The name of the party shall be **Bharat Uday Party of India** (hereinafter referred to as "the Party").

## **Article II: Objectives**

The objectives of the Party shall be:

1. To uphold the sovereignty, unity, and integrity of India.
2. To strengthen INCOME TAX PAYERS of India
3. To encourage inclusive growth and equitable distribution of resources.
4. To promote social, economic, and political justice for all citizens of India.
5. To work towards eliminating poverty, inequality, and discrimination on the basis of caste, religion, gender, or region.
6. To pursue sustainable development and environmental protection.

## **Article III: Membership**

### **1. Eligibility for Membership**

Any Indian citizen who is not a member of any other political party and

subscribes to the aims, objectives, and principles of the Party may become a member.

**2. Process for Enrolment**

Membership shall be open to all individuals who: a. Fill out the prescribed membership form. b. Pay the membership fee as decided by the Party. c. Agree to abide by the Party's constitution, rules, and regulations.

**3. Termination of Membership**

Membership may be terminated if: a. The member violates the Party's constitution or rules. b. Engages in anti-party activities or gross misconduct. c. Resigns voluntarily by submitting a written notice. D. Engages in unlawful activities as per the constitution of India.

**Article IV: Organizational Structure**

**1. National Executive Committee**

The Party shall have a National Executive Committee, which shall be the highest decision-making body. The Committee shall be composed of the following:

- a. President
- b. General Secretary
- c. Treasurer
- d. National Office Bearers
- e. State Representatives

**2. State Committees**

Each state shall have a State Committee headed by a State President, which shall be responsible for implementing the Party's policies and programs at the state level.

**3. Local Committees**

District, city, and village-level committees shall be established to promote the Party's agenda at the grassroots level.

**Article V: Leadership and Elections**

**1. Election of Party President**

The Party President shall be elected by the National Executive Committee for a term of 5 years subject to re-election.

**2. Election of Office Bearers**

Other national and state-level office bearers shall be elected in a similar manner through democratic internal elections.

**3. Internal Elections**

The Party shall hold periodic internal elections at all levels to ensure democratic governance.

**Article VI: Duties and Powers**

**1. National President**

The President shall: a. Represent the Party at all national and international forums. b. Preside over the meetings of the National Executive Committee. c. Provide overall guidance and direction to the Party.

**2. General Secretary**

The General Secretary shall: a. Be responsible for the day-to-day administration of the Party. b. Coordinate with various state and local units. c. Act as the principal spokesperson of the Party.

**3. Treasurer**

The Treasurer shall: a. Oversee the finances of the Party. b. Maintain records of all financial transactions. c. Present audited accounts to the National Executive Committee annually.

**Article VII: Code of Conduct**

1. All members and office bearers shall conduct themselves in a manner that upholds the dignity, discipline, and unity of the Party.
2. Members shall not indulge in any activity that brings disrepute to the Party or violates its constitution.
3. Corruption, favouritism, and discrimination shall not be tolerated within the Party.

**Article VIII: Finance and Accounts**

**1. Funding**

The Party shall raise funds through membership fees, donations, and

contributions from individuals, institutions, or organizations in accordance with the laws of India.

## **2. Financial Transparency**

The Party shall maintain transparent financial records and submit audited accounts to the Election Commission of India as per statutory requirements.

## **Article IX: Amendments to the Constitution**

1. Any amendments to this constitution must be proposed by the National Executive Committee or at least one-third of the State Committees.
2. An amendment shall be adopted if it receives a two-thirds majority vote from the National Executive Committee.

## **Article X: Dispute Resolution**

1. Any disputes arising within the Party shall be referred to a Disciplinary Committee appointed by the National Executive Committee.
2. The Disciplinary Committee shall investigate and resolve disputes in accordance with the principles of natural justice.

## **Article XI: Dissolution**

1. The Party may be dissolved if two-thirds of the National Executive Committee members vote in favor of dissolution.
2. In the event of dissolution, all assets and liabilities of the Party shall be disposed of as per the provisions of the law.
